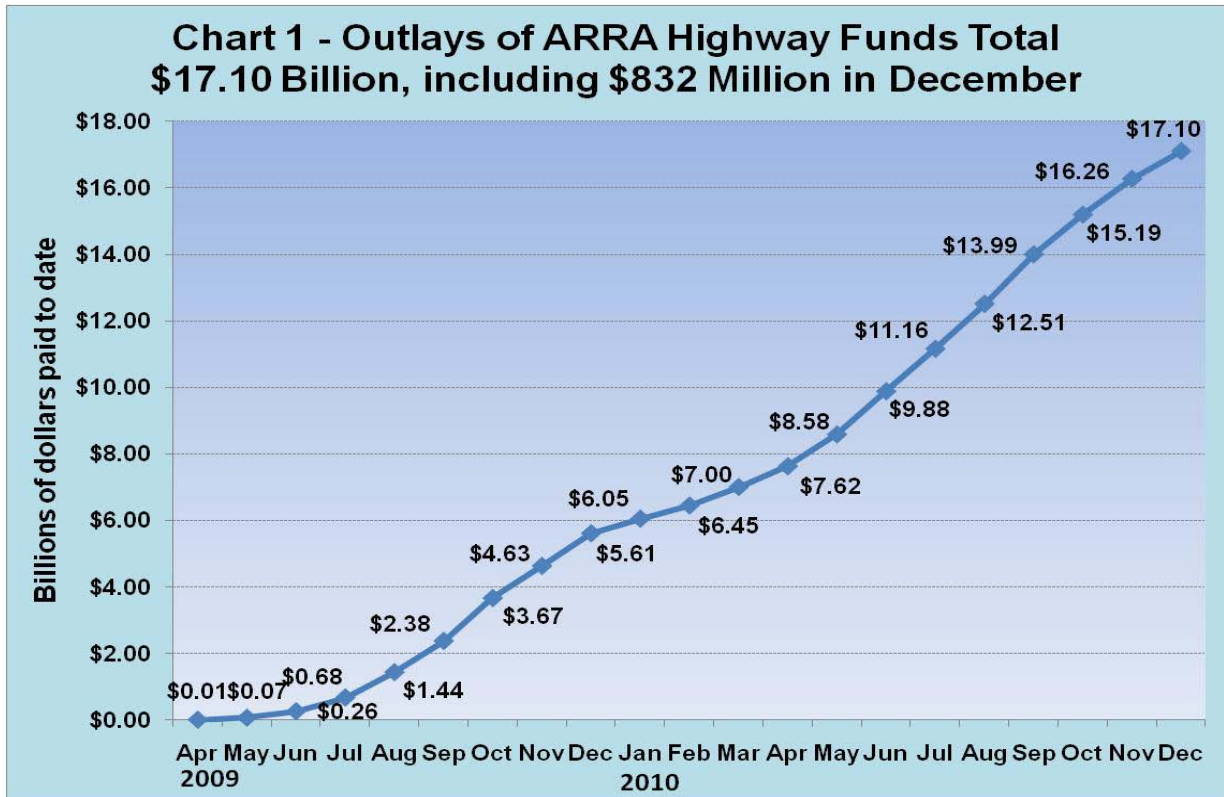

RE: UPDATE ON OBLIGATION OF ARRA HIGHWAY FUNDS

The attached charts and tables provide an update on the obligation and expenditure of American Recovery and Reinvestment Act (ARRA) highway funds as of December 31, 2010, based on data provided to ARTBA by the Federal Highway Administration:

- The ARRA required that all highway improvement funds be obligated by September 30, 2010. After that, no new projects can be added, and adjustments to funding for existing projects can be made only to accommodate a legitimate cost increase not related to a disputed contract claim or an increase under an escalation clause. Any deobligated funds must be returned to a centrally controlled account managed by the FHWA CFO. If a state applies to increase the amount obligated for a project, FHWA can approve or disapprove the increase although adjustments cannot exceed the total amount of Recovery Act funds apportioned to the state. Table 1 shows that a handful of states have a total of \$7.7 million of unobligated balances.
- In the last half of December, the U.S. Department of Transportation awarded \$195 million of Tiger I grants to 7 states, and the data are included in Tables 1 through 3 below. The December actions bring the total amount of Tiger grants awarded for highway and highway related projects to \$591 million, of which \$585 million has been obligated and \$115.8 million involves projects for which construction is underway.
- During December, outlays of ARRA highway funds by the FHWA totaled \$832 million, bringing total outlays to date to \$17.10 billion (see Figure 1). This means that 62.1 percent of the highway and TIGER grants apportioned or allocated to date among the states and federal lands have now been paid out (see Table 2 for state by state details). Most outlays are reimbursements to state and local governments for payments to contractors for work performed on ARRA-financed highway and bridge improvement projects.
- The \$17.10 billion of ARRA outlays to date include \$5.61 billion during calendar 2009 and \$11.48 billion during calendar 2010. The 2010 figure is just about what ARTBA projected based on data from the Congressional Budget Office. The last

two columns of Table 2 show state-by-state outlays during calendar 2009 and 2010.



- As of December 31, 2010, state and local governments in Texas continue to lead in outlays, at \$1.22 billion, with California second at \$1.14 billion and Illinois third at \$765.0 million. Twenty-two other states have paid out more than \$250 million.
- Wyoming has paid out 94.4 percent of its ARRA highway funds, the most of any state. South Dakota follows at 93.5 percent, then Iowa and Vermont at 92.7 percent and Utah at 92.5 percent. Other states above 80 percent include Alaska (86.2%), Idaho (80.1%), Indiana (80.7%), Maine (89.6%), Michigan (81.0%), Minnesota (82.1%), Mississippi (87.1%), Montana (89.4%), Nebraska (80.2%), New Hampshire (80.9%), North Dakota (88.9%), Oklahoma (86.6%), West Virginia (81.4%) and Wisconsin (83.1%). The state with the lowest outlays to date is Virginia at 24.1 percent. Note that calculations include Tiger 1 grant funds.
- The ARRA permitted recipients to obligate highway funds for non-highway improvements. A total of twenty-eight states flexed \$528.8 million of ARRA highway funds to non-highway uses, including \$443.0 million to transit projects and \$85.7 million to freight rail, passenger rail or port infrastructure projects. The total represents 1.94 percent of ARRA highway funds. State-by-state details are in Table 1.

- With virtually all ARRA highway investment funds now obligated, the table below provides the latest summary of ARRA highway funding¹. State and local government recipients obligated just under \$26.4 billion for 12,931 projects, including 5,969 that have been completed and 5,988 that are under construction. When projects on federal lands and TIGER 1 projects are included, the grand total comes to \$27.2 billion obligated for 13,366 projects.
